RESOLUTION 21-10

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLEMAN CONTINUING AND EXTENDING THE MAYOR'S DECLARATION OF A LOCAL STATE OF DISASTER IN THE CITY OF COLEMAN CAUSED BY SEVERE WINTER WEATHER

WHEREAS, on February 12, 2021, Governor Greg Abbott issued a Declaration of State of Disaster in all 254 counties in Texas due to severe winter weather which posed an imminent threat of widespread and severe property damage, injury and loss of life due to prolonged freezing temperatures, heavy snow and freezing rains statewide; and

WHEREAS, City of Coleman Mayor Tommy Sloan issued a declaration of a Local State of Disaster in Coleman, Texas on February 16, 2021 due to severe winter weather which led to prolonged loss of electrical power, dangerous road surfaces and unsafe infrastructure within the City, including, loss of the ability to treat water, loss of the ability to treat sewage, line breaks, and threatening the safety and lives of all residents; and

WHEREAS, the City of Coleman and Coleman residents continue to experience interruption of water supply to their homes and businesses, including currently under a boil water notice, and property damage to their homes and businesses due to the extreme weather conditions; and

WHEREAS, Section 418.108(b) of the Texas Government Code authorizes the continuation of a declaration of a Local State of Disaster with the consent of the governing body of a political subdivision; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLEMAN, TEXAS;

- 1. That the declaration of a Local State of Disaster for the City of Coleman made by Mayor Tommy Sloan on February 16, 2021 due to the severe winter weather, attached hereto as Exhibit "A", is hereby continued and extended in Coleman, Texas with the consent of the City Council through 11:59 P.M. on March 24, 2021.
- 2. That the declaration of a Local State of Disaster and this resolution continuing and extending the declaration shall be given prompt and general publicity and shall be promptly filed with the City Secretary as required by Section 418.108(c) of the Texas Government Code.
- 3. That this resolution is effective immediately and will remain in effect until 11:59 P.M. on Monday, March 24, 2021, whereupon it will expire unless continued by the City Council.

CITY OF COLEMAN WINTER WEATHER EMERGENCY DECLARATION

WHEREAS, on February 12, 2021, Governor Greg Abbott certified that severe winter weather poses an imminent threat of widespread and severe property damage, injury and loss of life due to prolonged freezing temperatures, heavy snow, and freezing rain statewide and declared a state of disaster for the entire state; and

WHEREAS, the severe weather has moved into the City of Coleman, and has led to prolonged loss of electrical power, dangerous road surfaces, and unsafe infrastructure within the City, including, loss of the ability to treat water, loss of the ability to treat sewage, line breaks, and threatening the safety and lives of all residents; and

WHEREAS, the City of Coleman has determined that extraordinary measures must be taken to minimize the negative effects of the weather event and to protect the health and safety of the community; and

WHEREAS, the City of Coleman urges all residents to stay home if they can, to seek shelter in facilities provided by the City, avoid driving if possible, and to take all cautionary measures to ensure the safety of all persons and animals in their care; and

WHEREAS, pursuant to the Texas Disaster Act of 1975, the mayor is designated as the emergency management director of the City of Coleman, Texas, and may exercise the powers granted to the governor on an appropriate local scale; and

WHEREAS, pursuant to the authority granted to the Mayor under the Texas Disaster Act of 1975, I authorize the use of all available resources of state government and political subdivisions to assist in the City's response to this situation; and

NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF THE CITY OF COLEMAN, TEXAS:

- 1. That a local state of disaster caused by the winter weather emergency is declared for the City of Coleman, pursuant to §418.108(a) of the Texas Government Code.
- 2. Pursuant to §418.108(b) of the Texas Government Code, the local state of disaster prompted by the winter weather emergency shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the City Council.
- 3. Pursuant to §418.108(c) of the Texas Government Code, this declaration of a local state of disaster due to the winter weather emergency shall be timely communicated to the public and shall be filed promptly with the City Clerk.
- 4. Pursuant to §418.108(d) of the Texas Government Code, this declaration of a local state of disaster because of a winter weather emergency activates the City of Coleman emergency management plan.
- 5. This proclamation shall take effect immediately from and after its issuance.
- 6. As Mayor, I further reserve all other authority and powers conferred by state law to respond as necessary to this situation.
